##### **Travel Permit for Newborn Baby:**

The applicant is required to submit following documents to the Mission while applying for Travel Permit for Newborn Baby (s):

1. An application form Parents
2. Birth Certificate of Baby/Babies issued by Local Municipal Corporation
3. Birth Certificate of Baby/Babies issued by local Govt. of Bangladesh.
4. 02 (Two) recent Passport-size photos of baby/babies with white background
5. Passport & Visa copy of the parents
6. Marriage certificate of parents
7. Discharge certificate from Hospital
8. National Identity Card (NID) copies of Parents
9. Fees: NEFT of Rs. 1800.00 (One Thousand Eight Hundred) in favour of Bangladesh High Commission, New Delhi (You have to pay here using your debit or credit card).

##### **Travel Permit for Lost Passport:**

The applicant is required to submit following documents to the Mission while applying for Travel Permit for Lost Passport:

1. An application form Applicant.
2. Applicant's Passport & Visa copy
3. FIR copy of local police station
4. Form-C/Residence proof
5. 02 (Two) recent Passport-size photos white background.
6. National Identity Card (NID)/Birth Registration Certificate (BRC) copy of Applicant
7. Fees: NEFT of Rs. 1800.00 (One Thousand Eight Hundred) in favour of Bangladesh High Commission, New Delhi (You have to pay here using your debit or credit card).

##### **Travel Permit for Passport Expiry:**

The applicant is required to submit following documents to the Mission while applying for Travel Permit for Passport Expiry:

1. An application form Applicant.
2. Applicant's Passport & Visa copy
3. Form-c/Residence proof.
4. 02 (Two) recent Passport-size photos white background.
5. National Identity Card (NID)/Birth Registration Certificate (BRC) copy of Applicant
6. Fees: NEFT of Rs. 1800.00 (One Thousand Eight Hundred) in favour of Bangladesh High Commission, New Delhi (You have to pay here using your debit or credit card).

### **Travel Permit for Victims/Detainees:**

The applicant is required to submit following documents to the Mission while applying for Travel Permit for Victims/Detainees:

1. An application form Applicant.
2. Proof of Nationality
3. Court Release Order/Deportation order from India Government
4. 02 (Two) recent Passport-size photos white background (35×45 mm)
5. NEFT of Rs. 1800.00 (One Thousand Eight Hundred) in favour of Bangladesh High Commission, New Delhi (You have to pay here using your debit or credit card).
6. [N.B.- The Mission will issue Travel Permit (T.P.) after receiving the above-mentioned documents and once the nationality of the detainees/victims has been verified by the appropriate authority of Bangladesh]

### **05. Repatriation Of Dead Body**

For repatriation of a Dead Body to Bangladesh the following documents should be submitted/emailed to the Mission:

1. Request Letter from the Relative/Attendant (Available at the Website)
2. Undertaking letter from the Relative/Attendant and Undertaker/Agent
3. Death Certificate from Hospital.
4. Passport & Visa copies of deceased and relative.
5. NOC from local police station.
6. Fees: No Fees Applicable.
